1. Call to Order-

Upon reaching a quorum, the meeting was called to order by Bob Bing at about 12:38pm. The meeting proceeded according to the proposed agenda.

2. Approval of agenda –

Addition of the following items were suggested:

- a. New item 4.e: Support for Jane Hutchison's campaign (Wayne Board of Education membership)
- b. New item 4.f: Compensation to members negotiating on the Master Agreement Team
- c. Renumber 4.e as 4.g.
- Motion: To approve the agenda as amended above:

Moved by Al Montare, seconded by David Stern. The motion passed.

3. Approval of Minutes of March 13, 2003

One amendment was suggested: It should include an amendment to append 2/13/03 meeting minutes on the last sentence of p.3 to read as "This will be included as part of our next Master Agreement".

Motion: To approve the minutes of 03/13/03 meeting as amended:

Marion Turkish moved, Bob Murphy seconded. The motion passed. Note: Contact Aria Cheo after the meeting if any additional changes are needed

- 4. President's Report- Bob Bing:
 - a. A moment of Silence in Memoriam for Neil Grant:

Bob Bing asked members to offer a moment of silence in memoriam for Neil Grant, a strong Union supporter, colleague and a friend, who just passed away. Members did so by standing in silence.

b. Report on AFT Higher Education Conference:

Bob Bing, Sue Tardi and Linda Gazzillo attended the conference in Atlanta. It was informative and useful. The workshops were the best part of the Conference. Bob Bing attended two workshop sessions, Strategic Planning and Budget and Federal Higher-Ed Act Impacts. He gained many insights regarding each area. Sue Tardi added that she learned a great deal from the workshops on Distance Learning and the Politics of State Government. Linda Gazzillo attended workshops on Health Benefits and also found them to be informative. Nick Yovnello, Our State AFT Local President, chaired the session. Bob Bing commented that Nick refused to buy tickets to attend the Governor's fund raising event. He wants to see a strong governor's support for Higher Education in New Jersey to materialize in order to merit our support. AFT National President, Sandra Feldman, came to New Jersey to attend this fund raising event and offered to pay for AFT tickets. Nick rightfully refused and explained that by not purchasing tickets we are making a strong, unified statement: AFT checkbook is closed until the Governor provides the support we need and that he promised.

- c. Our thanks to Robert Harris for his Service as the Communication Officer: Bob Bing thanked Robert for his service as Communication Officer for the past three years.
- d. Legislative Breakfast-4/16/03- Hobart Manor from 8:45-10:15am.

Bob Bing reminded the members of this event, and urged all to attend. Senator John Girgenti and Nia Gill, a rep from Senator Byron Baer and Assemblyman Johnson responded positively to our invitation. President Speert and two Representatives from the Provost's office, Dr. Stephen Hahn and Dr. Pedro Martinez, will attend. The main issue we will share with the legislators is the budget cuts imposed on State Higher Education Institutions. We have already begun to see an increase on the faculty and staff workload without compensation.

e. Local 1796's support to Jane Hutchison's campaign for Wayne Township Board of Education membership-

Bob Bing explained the rationale for the Executive Committee's recommendation to support Jane's election. The committee recognized the continuous contributions that Jane has made to our Local, especially regarding her efforts in providing the Strike Headquarters free of charge four years ago.

Motion: To support Jane Hutchison's campaign to gain a seat on the Wayne Township Board of Education by providing a financial contribution of \$100 to her campaign fund.

Moved by the Executive Committee, seconded by Linda Dye. The motion carried.

- f. Compensation to members of Master Agreement Team.
 Bob Bing and sue Tardi explained the background and need for this provision. A motion was entertained from the floor:
 - Motion: To compensate two non-officer members of the team, Bob Wolk and Linda Dye to receive \$100.00 per negotiation session throughout the entire negotiation period (retro-active to March 2003), and Judy Matthew for the summer negotiation while she will not receive any summer stipend from the Local. The Executive Committee moved, Marjorie Goldstein seconded. The motion passed.
- g. Thanks to Local 1976-

Bob Bing thanked the members again for their support for the past 14 years while he served as VP for Grievance and then as the President. The members honored him once again by a standing ovation. Linda Dye added her deep gratitude to Bob Bing for his help to her and his dedication to the Local.

Copies for the proposed budget were circulated. Diana explained each item in detail and asked members to be ready for voting at next meeting. Diana announced that we would invite Vincent Baldassano, our investment consultant, to make a presentation on the state of our investment at the next meeting.

- 7. Report from the Nominating Committee and Election Committee- Marion Turkish and Jean Levitan

Bob Bing explained the procedure. Marion will present the Slate (second reading). Should any position have more than one candidate then Jean Levitan will conduct an election. Sue Tardi explained that the Responsibilities of the Officers whose positions are not clearly defined by the current Constitution.

Comments from the members: Only one title should be used, either all with "Officer" or "Representative" for Librarian, Professional staff and Adjunct Faculty. Sue Tardi agreed to clear up the matter to reflect consistency.

Marion Turkish proceeded to present nomination from the Slate

- a. Executive Committee Officers:
 - 1. President- Sue Tardi. There were no other nominations. Bob Bing asked the Recording Secretary to cast a single vote to elect Sue Tardi as the President. The Secretary did so. Sue Tardi was duly elected as the President of AFT Local 1796, 2003-2004.

Sue Tardi then assumed the Chair of the meeting from this point on. Marion Turkish continued to present the slate:

Charles urged the Council members to encourage faculty to come to talk with the Union officers before going through the appeal process with the President. These successes are primarily due to the Union's leadership.
